Ragui Assaad is regional director for West Asia and North Africa at the Population Council. He has over 20 years of research experience on gender, poverty, and labor market and is an expert on statistical and econometric modeling using household survey and census data. Before joining the Population Council, Assaad served as professor of planning and public affairs at the Humphrey Institute of Public Affairs at the University of Minnesota. Assaad has a PhD in City and Regional Planning from Cornell University. He also holds a B.Sc. in physics and an M.Sc. in mechanical engineering from Stanford University.

Mohamed Z. Bechri is currently senior economist with the Central Bank in Abu Dhabi. He holds a PhD in Economics from the University of Southern California. He taught economics at the University of Tunisia and worked at the African Department of the International Monetary Fund in Washington. His main field of interest is Development Economics, New Institutional Economics and Political Economy.

Mohamed Abdelbasset Chemingui is a research scientist at the Techno-economics Division of the Kuwaiti Institute for Scientific Research (KISR). Before joining KISR, he has worked as associate researcher with the University of Montpellier and as research assistant and economist at the OECD Development Center (1998 and 2000). He has a PhD in economics from the University of Montpellier (France) in 2000. He was awarded a first place with a medal prize for his study on income distribution in Tunisia under the Second Global Awards Competition organized by the Global Development Network in Rio de Janeiro in December 2001, and the best policy oriented paper in trade topic during the ERF 12th annual conference held in Cairo 2005. His research interest has been in partial and general equilibrium modeling, macroeconomics, international trade, and regional integration, labor market and poverty analysis, growth and productivity changes, and agricultural and environmental economics. He has worked on projects sponsored by World Bank, ESCWA, European Commission, ETF, IDRC, ERF, GDN, IFPRI, UNIDO, API, and other national agencies in the capacity of Project Leader/Principal Investigator/Consultant.

Adam B. Elhiraika holds a PhD in Economics from the University of Glasgow (1991) and a Masters degree in Economics from the University of Kent at Canterbury. He taught Economics at Gezira University (Sudan), Fort Hare University (South Africa) the University of Swaziland (Swaziland), and the United Arab Emirates University. He is the author of several books and edited volumes, and is a co-developer of the econometric software package *Microfit*, published by Oxford University Press. He is a fellow of the Econometric Society, a fellow of British Academy and a recipient of one of the Royal Economic Society Prizes for the best article in the *Economic Journal*.

Christopher A. Pissarides is professor of Economics, London School of Economics. He has written extensively on the economics of labor markets. His book *Equilibrium Unemployment Theory* is a standard reference in the economics of unemployment. He is a fellow of the British Academy and the Econometric Society and Council member, European Economic Association and the Econometric Society. He is a research fellow of CEPR and IZA, a non-national senior associate, Economic Research Forum for the Arab Countries, Iran and Turkey and a member of the Cyprus Monetary Policy Committee. In 2005 he received, with Dale Mortensen, the IZA Prize in Labor Economics.

Djavad Salehi-Isfahani graduated with a PhD in Economics from Harvard University in 1977. He is currently professor of Economics at Virginia Polytechnic Institute and State University in Blacksburg, Virginia. He has taught at the University of Pennsylvania, 1977–1984, and was visiting faculty at the University of Oxford (1991–1992).
