

STUART BLASHFIELD REA COOKE, son of the late Mr. John Dunne Cooke, of Brampton Brian, Herefordshire, was born on the 17th October, 1871, and was educated at Cheltenham College and the Crystal Palace Engineering School. He obtained his engineering training in the office of Messrs. Meik and Sons, Civil Engineers, Edinburgh, by whom he was employed chiefly on railway and harbour work. Thus equipped, he obtained an appointment in 1898, under the late Sir William Shelford, as an assistant engineer on railway construction in West Africa, where the remainder of his unfortunately brief engineering career was passed. In 1899 he became Resident Engineer for Messrs. Coode, Son and Matthews at Old Calabar, where he carried out important harbour works, and on their completion in 1904 he made a survey of the Gambia River. In 1905 he superintended for the same firm the construction of harbour works at Accra, and it was whilst engaged on this task that he met his death, as the result of a carriage accident at Accra, on the 12th July, 1908. By the untimely death of Mr. Cooke, the Colony was deprived of a thoroughly efficient officer at a time when his special knowledge and experience were of the utmost service, whilst the coast community is the poorer by the loss of an attractive personality.

Mr. Cooke was elected an Associate Member of The Institution on the 2nd March, 1897.

EDWARD HUNT, third son of Henry Wallis Hunt, of Alley Park, West Dulwich, died at Algeciras, Spain, on the 20th June, 1908, aged 42. At the time of his death, he occupied the position of Chief Engineer of the Algeciras (Gibraltar) Railway. Born on the 15th October, 1865, he received his practical training on the Great Northern Railway, and remained attached to the staff as Assistant Engineer for 3 years after the expiration of his pupilage. At the end of 1888, he left England for Argentina to join the construction staff of the Buenos Ayres Great Southern Railway, and was placed in charge of the Las Flores section of the line. In 1893 he accepted the appointment of General Manager to the Venezuela Central Railway, which he retained until January, 1898. He next went to Cuba as Chief Resident Engineer of the United Railways of Havana, resigning that post in 1900. After an interval at home, he left for Spain, to take up the position of Assistant

Engineer on the Algeciras Railway, and becoming Chief Engineer in October, 1903, he held this post until his death.

Mr. Hunt was elected an Associate Member of The Institution on the 2nd February, 1892.

WILLIAM INGLIS was born at Perth on the 15th October, 1856, and was educated at Burntisland and at Edinburgh Royal High School. He served his engineering apprenticeship on the staff of the North British Railway Company at Edinburgh, commencing in October, 1872, under the late Mr. James Bell, then engineer-in-chief to the Company. In February, 1882, Mr. Inglis was appointed maintenance engineer of the Northern Division of the North British system, which embraced all the company's lines north of the Forth. During the completion of the Arbroath and Montrose Railway and the reconstruction of the bridge over the River South Esk at Montrose, Mr. Inglis was brought into close contact with Sir William (then Mr.) Arrol, and when the latter secured the contract for the construction of the second Tay Viaduct in 1882, he appointed Mr. Inglis his resident engineer, a position which he ably filled until the completion of that great undertaking in 1887. Mr. Inglis subsequently acted in a similar capacity for Sir William Arrol on the Forth Bridge Connecting Lines which run from the south end of the bridge to the Edinburgh and Glasgow Line of the North British Railway at Corstorphine on the east and at Winchburgh on the west. He also superintended the construction of the road bridge across the Tay at Caputh. In 1891 Mr. Inglis accepted a partnership in the well-known firm of Messrs. William Bain and Company, Lochrin Iron Works, Coatbridge, and took an active part in the direction of the business until his death.

In addition to his arduous professional labours, he devoted much time to local affairs. He was a baillie of the town of Airdrie, an active member of Broomknoll United Free Church, and was associated with various friendly and benefit societies established in the interests of the working-men of Airdrie and the district. Mr. Inglis died at his residence, Rosedale, Airdrie, on the 18th May, 1908, leaving a widow, three sons and five daughters.

He was elected an Associate Member of The Institution on the 1st February, 1881.
